He is supported by a strong and experienced board, with geoscientist Shane Sadleir in the role of managing director, Ralph Winter as commercial director and Adrian Larking, ex-WMC lawyer and geologist, as non-executive director.


The technical team is headed up by Exploration Manager Bob Affleck and Principal geologist Max Nind.

They are backed by a number of consultants including world-renowned geologist Dr Jon Hronsky, who was responsible for the discovery of the Nebo-Babel deposits in WA – considered to be the largest nickel-sulphide find since 1993.


